### **About Positive Money:**

Positive Money is a fast-growing research and campaigning organisation. We campaign to reform the money and banking system. Current monetary policy and the money system cause a wide range of economic, social and environmental problems; most notably house price bubbles, high levels of debt, and rising inequality. Our vision is for a money and banking system that supports a fair, democratic, and sustainable economy.

### **About the role:**

This internship position provides an opportunity for an individual who wishes to gain practical experience of campaigns, public affairs and media relations. You will be given distinct projects based on your skills and interests, although you will also be involved in a variety of activities arising on an ad hoc basis and undertake some administrative work. You will work as part of the influencing team to build awareness of our campaign, support parliamentary interventions, influence policy and respond to political and economic events.

The role will be varied but tasks may include

- Writing policy briefings
- Managing correspondence with stakeholders
- Drafting campaign communications
- Assisting with the planning and management of events
- Media monitoring
- Assisting with research
